Mr. Stegall moved to Approve the employment of staff for the Alternative Day Summer Enrichment Program funded by the ESSER grant running June 14-July 21, 2022 for a total of 60 hours as presented. Second Ms. Evans ROLL CALL VOTE ALL AYES: Evans, Goselin, Stegall (256), and Stegall (302).

Ms. Evans moved to Approve the contractual employment of Lisa Stalnecker for human resources, payroll, and financial services for the 2022-2023 school year for a stipend of \$13,440 (plus IMRF and FICA) paid as a purchase service on a quarterly basis. This is representative of a 3% increase from the 2021-2022 school year. Second: Mr. Stegall ROLL CALL: ALL AYES: Evans, Stegall (256), Stegall (302), and Goselin

Mr. Stegall moved to Approve the contractual employment of Jill Cowsert for accounts payable and secretarial services for the 2022-2023 school year for a stipend of \$20,193 (plus IMRF and FICA) paid as a purchase service on a quarterly basis. This is representative of a 3% increase from the 2021-2022 school year. Second: Ms. Evans ROLL CALL: ALL AYES: Evans, Stegall (256), Stegall (302), and Goselin

Mr. Stegall moved to Approve a 3% salary increase for Kori Giacometti, Alternative Day Program Administrator for the 2022-2023 school year beginning July 1, 2022. Dr. Goselin moved to **Approve a 4% salary increase for Debra Quain, Executive Director for July 2022 through June 30, 2023.** Second: Ms. Evans ROLL CALL: ALL AYES: Evans, Stegall (256), Stegall (302), and Goselin
