Board members received the Director's report in their mailing. Ms. Quain's report included:

D. Web-based IEP System

Further discussion regarding a change in IEP web-based systems was had with the District Director group. At this meeting three districts voiced wanting to remain with PCG's EasyIEP and four districts wished to implement the Embrace system. Although KASEC would like for the Cooperative to remain cohesive and have all seven member districts utilize the same IEP system, it has asked PCG what the possible ramifications would be if some of its member districts would break away and use a different system. KASEC is waiting the response.

E. Health, Dental, Vision Renewal for December 1st

The Director shared the renewal costs for health insurance. KASEC's Insurance Committee wished to remain with its current health plans. The overall percentage increase was just over 13%. Vision and Dental costs remained the same for this renewal.

ACTION ITEMS Dr. Goselin moved to Approve the full time employment of Megan Tavares, 1:1 Paraprofessional for the Communications Program, at a prorated salary of \$13,930 for 113 days effective November 18, 2022. - 7. OTHER Mr. Stegall verbally acknowledged Ms. Quain's continued efforts in balancing her Director duties while subbing in the Communications Program. He praised her for willingness to continue to working longer hours to make sure everything gets done.
