All teams have completed TCI training, provided by Kori Giacometti and Emily Smith They will continue to provide initial training and refreshers for staff. An Adaptive PE training with Brian Anderson from BBCHS will be held December 13 at the St. Anne District Office for member districts interested in adaptive p.e. lessons. KASEC has partnered with I-Kan to present a Behavior Assessment Project through SIU on January 6, 2025 at Kankakee Community College.
