D. 2025-2026 SERVICE ASSESSMENT FEE STRUCTURE

The Finance Committee met on March 21, and a fee structure for service assessments was presented to the Board. Discussion ensued regarding further fees for non-district members. It was recommended that the Finance Committee meet again and report back at the May Board meeting.

E. WEBSITE UPDATE

KASEC's website needs to be updated. SugarWebs quoted \$2500 to complete the update, which the board approved.

G. <u>OTHER</u>

The Director partnered with Project Sun to share community-based resources with area pediatricians.

Dr. Palan to Approve a 3% salary increase for Lindsey Coffey, Director, and an additional 3 sick days for the 2025-2026 school year. Second: Mr. Hammond ROLL CALL: ALL AYES: Smith, Palan, Stegall, Hammond, and Maxwell.

Mr. Stegall moved to Approve a 3% salary increase for Kori Giacometti, Program Coordinator, 3 additional sick days and 5 additional days on her contract (210 days) for the 2025-2026 school year. Second: Dr. Smith ROLL CALL: ALL AYES: Smith, Palan, Stegall, Hammond, and Maxwell.

Dr. Maxwell moved to Approve a 4.5% increase for non-union employees, Teresa Smith, COTA, and Karin Zylka, Audiologist, for the 2025-2026 school year. Second: Dr. Terrell-Smith ROLL CALL: ALL AYES: Smith, Palan, Stegall, Hammond, and Maxwell.

Dr. Smith moved to Approve a 4.5% increase for contracted bookkeeping/human resource services for Lisa Stalnecker and Jill Cowsert for the 2025-2026 school year. Second: Dr. Palan ROLL CALL: ALL AYES: Smith, Palan, Stegall, Hammond, and Maxwell.
